1. Introduction and background

The major themes of the research of the Centre remain the broadly defined exploration of Jewish cultures and Jewish/non-Jewish relations in the widest sense. The Centre's activities, in particular in doctoral and early career researcher training (see Table 5), innovative modern Hebrew teaching and cross-institutional collaboration in the North of the British Isles, are currently being boosted by a £269,381 external grant, to be continued in 2018–22 by another £410,071 grant.

The Centre continues to function as an initiator, facilitator and host for external research grants and the research of individual post-doctoral fellows, which included two British Academy post-docs. Members of the Centre were managing research related grants to the total value of £494,808 and of £738,269, if the non-research component of the European Regional Hub of Jewish Studies grant is included. This includes the funding for one dedicated CJS post-doc (Silvestri), but does not include additional external funding tied to three other post-docs affiliated to the CJS (£455,953). The Centre maintains a high international profile for the research of Manchester University academics by aggregating and maximizing awareness of their activities, projects, grants and publications, as well as by its public lecture series (disseminated as podcasts), visiting academics (including a Faculty of Humanities Simon Visiting Professorship), and the online journal Melilah edited from the Centre. It effective, up-do-date comprehensive (http://www.manchesterjewishstudies.org/) complemented by a twitter presence. The Centre brings together staff at home in different divisions of the School and different Schools of the University, and supports and collaborates with the John Rylands Research Institute (JRRI) in promoting the important research resources of the Library.

3. Objectives and progress made over the 12 month period

European Hub for Jewish Studies. The reporting period contained the final year of funding received into the University of a 2.5-year total of £269,381 by an external European foundation. The grant is for some of the Centre's activities in the period January 2016—August 2018. The Centre has been awarded a further 4 years of funding of £410,071 for the period September 2018-August 2022.

Catalogues, Research dissemination of John Rylands Holdings: Collaboration with the John Rylands Research Institute continues to be strong, with work funded by a £120,000 Rylands Hebraica grant ongoing (Smithuis), which was renewed for another £90,000 with effect from October 2018. The British Academy post-doctoral research on Gaster (Keim, Cioată) also continued. Prof. Brad Sabin Hill (Washington), who was Simon Visiting Professor in June-July 2018, produced catalogues of Moses Gaster's printed Hebrew and Yiddish books held at the John Rylands, after earlier writing the Research Guide to the Marmorstein Collection following his visit to the Centre last year (November 2017).¹

Information exchange and informal mentoring of staff research applications: Again, as a result of European Hub grant funding, our extremely successful facilitation of research dialogue across discipline boundaries and University subject areas continues has significantly increased beyond the University's boundaries.² A research network meeting took place in June 2018 involving Jewish Studies academic staff from Northern UK Partner institutions, although attendance was weaker than in earlier years (we are rethinking the model for these meetings for 2019). The School's Research Grant Writer, Dr Aaron Mcgaughey, and Research Manager, Ms Raksha Parma, as well as Mr Ed Salter, presented funding information at the meeting. Throughout the year we continued to provide a meeting ground for academics to share formal information, exchange informal advice, and experiment with ideas across a number of different subjects within SALC, in particular between members in AMES, R&T, History, French and Drama, and a meeting of Manchester CJS members to discuss future strategy took place 9 May 2018.

Manchester's Centre for Jewish Studies has a strong digital humanities profile. This includes, but is not restricted to, academic outputs. The following aspects and techniques should be mentioned:

1. Dissemination of Research: Podcasts (CJS Bogdanows, CJS Shermans); Open Access journals (CJS Melilah; see under 9); Online exhibitions (CJS Manchester and Zionism exhibition); Social media (CJS twitter and newsblog accounts), linking to open source scholarship in PURE.

- 2. New Research Approaches and Methodologies: Cataloguing online (e.g. Rylands Hebraica catalogue); Metasites (CJS Laski online web listing); Digitising existing publications as e-texts (CJS Old Series of Melilah);⁶ Gathering, digitising, tagging/indexing large amounts of primary sources or MSS (Rylands Genizah); Digitizing and indexing/tagging audio (CJS Oral testimony archives at Manchester Jewish Museum); Creating new e-resources using the model of existing publications (e.g. CJS Darwin's Jews Online reader);⁷ Creating new e-resources that are only possible as DH projects, such as multi-media digital archives and databases (e.g. CJS Samely Typology project).
- 3. Language Teaching: Integrated use of smart board and video-conferencing technologies (GotoMeeting and swivl robot) and smartphone technologies for the dissemination of and interaction with the teaching of Hebrew beyond the classroom.⁸

National and international presence of the CJS, early career researchers and miscellaneous: CJS staff continue their strong research publication profiles in preparation REF 2020 (see Appendix), and CJS scholars maintain a strong academic and public profile (some details in section 7 below). Our website has again attracted international attention (20,000 page views in last 12 months), as does the online journal *Melilah* (108,303 page views in the last 6 years; see below). Our channels of communication include website, newsblog, email list and Twitter. We successfully completed 3 years of developing a pioneering a new way to teach modern Hebrew in the class room, with combined face to face and virtual interaction. This constitutes one of the key activities funded by the European foundation mentioned above. and also contributed to the training of 3 Manchester University PG students. Contributors from Manchester to the British Association for Jewish Studies (BAJS) Conference 2018 included Dominika Cholewinska-Vater, Katharina Keim, Marcel Stoetzler, Adi Bharat and Edmund Chapman.

Objectives stated in previous year's report and provide details of progress to date against planned deliverables and milestones

- 1. The CJS activities throughout 2017–18 were significantly enhanced and expanded by the award of a £269,381 grant for the period Jan 2016–Aug 2018 from a private European foundation (see above under 1). In early 2018, Manchester was awarded a second tranche of this grant. We remain the sole UK representative of the European Regional Hubs (one of seven in Europe, and the largest). We are the Hub of the Northern UK Jewish Studies Partnership, linking with academics from Leeds, Durham, Edge Hill, Chester, Bangor, Nottingham, Trinity College Dublin, Edinburgh and St Andrews. - 2. The fourth research meeting of the Northern UK Jewish Studies Partnership took place 27 June 2018.
- 3. The third doctoral and post-doctoral research training workshop took place on 26-28 June 2018 in the Graduate School. It included a hugely successful mock exercise for making a large grant AHRC application, supported by SALC Research Office staff (see above). We were able to provide 17 travel stipends for participants from the Northern Partner institutions and other UK Universities. This event was recognized by the North West Consortium Doctoral Training Partnership.

- 4. Following the success of our new Hub application (from September 2018), we were able to enhance SALC MA Programmes by awarding for a third year CJS-funded MA fee bursaries for the MA Religions and Theology with a Jewish Studies focus.
- 5. The first "Sherman Conversation" (Sept 2017), on "Judaism and Gender Studies", which for the first time replaced the formal four-day Sherman lecture series with a more conversational, research-oriented day-long format, attracted prominent international experts in Jewish gender studies. It proved that the new format works well, and that Manchester doctoral and early career researchers find it extremely beneficial. A volume with papers arising from the event is planned, as issue of the Manchester Jewish Studies journal *Melilah* (eds. K. Stuerzenhofecker, R. Smithuis, H. Morse).
- 6. We organized the twenty-fourth Sherman Lecture, presented by Prof Asaf Siniver (University of Birmingham), and the fourth Bogdanow Holocaust Lecture Series, presented by Prof. Jan Grabowski (University of Ottawa) to great topical interest (the Polish law against claiming that Poland was responsible or complicit in Nazi crimes). 8. Social Responsibility

Our centre organises or supports a number of activities related to our research which aim to make a social responsibility contribution. In addition to ad hoc and individual public engagement events for local Jewish and other faith group communities (see points 4 and 7 above, and Appendix below), these include:

- the Shermans Community Lecture on a theme of topical interest with the **Jewish community** agreed with community representatives (see above)
- auditing fee bursaries which allow three **Jewish community leadership representatives** or their nominees to learn modern Hebrew as part of their professional development
- individual interventions of Centre members in current debates to promote social cohesion in the UK in the context of religious literacy, such as (1) Prof. Langton's earlier membership of the Archbishop of Canterbury's Jewish Forum, as well as his contributions to the development of Religious Studies A-Level curriculum, and (2) Prof. Samely's 2018 policy@manchester blog in On Cohesion, 'Could religious tradition be the antidote to fundamentalism?' (http://documents.manchester.ac.uk/display.aspx?DocID=37483)

10. Statement of planned activities for the next 12 months

- 1. 2018-19 will see the beginning of a suite of new Centre for Jewish Studies activities, to be funded from the above-mentioned grant of £410,071 for the period Sept 2018 Aug 2022 (see above under 1): These will include:
- 1. The "50 Jewish Objects" three-year research and public engagement Project, which starts in October 2018 and to which Dr Stefania Silvestri has recently been appointed (funded from the new European Regional Hub of Jewish Studies grant, see above). Initial blogs and website publications are expected from 2018–19.
- 2. Workshops, displays and performances by artists and performers directed at the general public in Manchester and Northern Partnership locations, which relate to these objects and arising from the original research which Dr Silvestri will conduct. These will be commissioned from 2018–19.
- 3. Our fourth post-graduate research-training workshop for UK advanced doctoral students and post-doctoral researchers. Feedback questionnaires from the earlier events were overwhelmingly and enthusiastically positive, and our event was considered pioneering in its mix of career advice, research "Current Trends" talks, and opportunities for one-to-one advice.
- 4. Enhanced collaboration between Manchester and other Northern UK Jewish Studies Partnership institutions, and a revamped network meetings of academics in the Northern British Isles Jewish Studies Partnership, using the framework of the new "50 Jewish Objects" project.
- 5. Further resource enhancement of research use of the holdings of the John Rylands University Library: this is part of the rationale of the "50 Jewish Objects" project. The result will provide selective descriptions of objects within an innovative narrative framework.
- 6. To host the fifth annual Bogdanow Holocaust Lecture Series. The speaker will be Prof. Tony Kushner (University of Southampton), on "Illegality: Jews and Other Humans", 23 24 September 2019.
- 7. Organising the twenty-fifth Sherman Community Lecture (speaker to be determined in consultation with the Education Committee of the Jewish Representative Council of Greater Manchester).
- 8. Continuing support for modern Hebrew teaching, located within LEAP from 2018–19, its pioneering combination of class room and online interactive delivery of teaching and student activities. Auditing fee bursaries and fee waivers (for students elsewhere in the UK) are available.
- 9. Continued grant application activity, both external and internal funding (SALC RSF, RNF, JRRI).

10. PhD projects starting include two funded ones: Katherine Halls will start her project under the supervision of Dr Behar, entitled: Marriage and Gender in the Egyptian Jewish Community, 1919-1960 Source of funding: AHRC (£4k fees + £14,500 maintenance p.a.) and UoM Presidential Award (£1k). Project dates: 2018–2021; PhD student Lawrence Rabone will start his project under the supervision of Prof. Langton, entitled: The Triumph of Philo-Semitism over Anti-Semitism and the Jewish-Christian Encounter in England, 1620-1656 Source of funding: AHRC (£4k fees + £14,500 maintenance p.a.) and UoM Presidential Award (£1k). Project dates: 2018–2021.

12. Teaching summary

Hebrew language teaching

The Centre is committed to maintain the availability of credit-bearing Hebrew language teaching (levels 1-3) for the significant number of Manchester University students who take our broad range of Jewish Studies courses. As planned, levels 1, 2 and 3 of Modern Hebrew were offered this year (2017–18). Next year there will be level 1 and 2 courses.

Fee bursaries for MA students in Jewish Studies

These bursaries are offered for MA students in Religions and Theology who choose Jewish Studies as their main study focus (support for 3 bursaries in academic years 2016-17 and 2017-18, respectively). Two bursaries have been allocated for the academic year beginning Sept 2018.

Postgraduate research training

The third postgraduate research-training event took place on 26-28 June 2018 at the University of Manchester. Around 25 PhD students and post-doctoral researchers (17 travel stipends) from the Jewish Studies Partnership institutions and other universities in the wider UK and continental Europe participated in a range of training and information sessions. The event has received emphatically positive feedback from participants for both years. A majority applied for financial assistance but from the verbal and written feedback it seems likely that a partial bursary would be adequate for next year. Another change in response to feedback will be to extend the programme.
